Karmaveer Dr. Bhaurao Patil earnestly desired to establish a law college in addition to Arts, Science, Commerce and Education Colleges. After his sad demise in 1959, Ismailsaheb Mulla, Honorary Secretary of Rayat Shikshan Sanstha took great efforts and received permission from Shivaji University to start a Law College in Satara. He selected able and eminent lawyers from the District Bar Association of Satara as honorary lecturers and established this college on 15-5-1968 affiliated to The Shivaji University, Kolhapur. On 15-02-1975 this college was named after Adv. Ismailsaheb Mulla, the renowned, selfless and dedicated Honorary Secretary of Rayat Shikshan Sanstha, who worked for 38 years in the honorary capacity.

Ismailsaheb Mulla Law College is doing a pioneering work in the field of legal education in Satara District and surrounding area since 1968. The college conducts Three Year Law Course, Five Year Law Course and Diploma Courses in Labour Law, Cyber law, Insurance and E-Banking. The college also conducts short term certificate courses in E-Banking, Insurance, Human Rights, Computer Skills and Personality Development. From Academic Year 2017- 18, the college has also started a study Centre for Company Secretary Course, in association with ICSI, Pune Chapter.

Personality Development and Soft Skills Syllabus

Objectives

In legal profession, personality is considered as important asset for a successful career. The course emphasis on practical skill development through competitions, group discussions, motivational lectures series, games, role playing etc.

Module I Personality Development

Introduction to personality, importance of personality and its impact, Influencing factors environment, thoughts on personality, importance of personality development.

Module II Goal

Importance of goal, setting a goal, planning/starting a goal, long term goal, short term goal, SMART principle, commitment, goal planning sheets.

Module III Time Management

Importance of time management, setting priorities, self diagnosis of time deployment, time planner, goal and time management correlation, quality / productive time, time management sheets.

Module IV Motivation

Factors affecting efficiency, Internal and external factors, Maslow's Hierarchy of Needs, self evaluation, test of self motivation, digital motivation lectures.

Module V Leadership

Role and importance of leaders, leadership in political, social, business etc, skills of leader, styles of leadership, ability for planning, organizing and coordination, negotiation skills, creative thinking, problem solving and decision-making, role-playing.

Module VI Communication

Importance of communication, communication as influencing skills, effective communication, barriers of communication, listening skill, art of public speaking, non verbal, verbal, written, interpersonal skills, business communication skills.

Module VII Presentation Skills

Overcoming phobia, debating skills, group discussion, presentation with slides, seminar presentation, writing skill development, CV writing, practical sessions.

Module VIII Attitude

Definition of attitude, psychological factors, importance of change in attitude, self evaluation, self awareness, positive thinking, 3 E's of attitude - Environment, Experience and Education.

Module IX Life Skills Education (WHO)

The ten core life skills prescribed by World Health Organization, self-awareness, empathy, critical thinking, creative thinking, decision making, problem solving, effective communication, interpersonal relationship, coping with stress, coping with emotion.
