participating or experiencing the actual process. Through the guidance of Dr. Deepa Patil, Adv. Amit Dravid, subject teacher motivated and encouraged students of LLB-III and NLC-V to participate in various programs. Brief Reports of these programs are as follows:

A) Industrial Visit at Beacon Gear Transmission Pvt. Ltd., Satara (Date: 29th September 2022)

Law College has organized Industrial Visit at Beacon Gear Transmission Pvt. Ltd., Old MIDC, Satara under the guidance of Adv. Amit Dravid, subject teacher and Adv. Nilam Pawar, Internship Coordinator. Students of LLB-III and NLC-V were present. The directors of the company Mr. Mahamulkar, Mr. Salunkhe gave important keypoints which are necessary for management of company. They even allowed students to ask questions to staff. Students asked many questions regarding Trade Union, Health and Safety Measures even Provident Funds and Bonus. Labour Court, Satara invited Law Students to attend Kamgar Din Program organized by Labour Court, Satara itself. Students of NLC-V and LLB-III participated in the program. Hon'ble Justice Anushree Rahane, Labour Court had given opportunity to students by allowing them to express their views. Students also expressed their thoughts on Labour Law. Amit Dravid delivered speech on subject 'Labour Laws and Constitutional Provisions'

5) Teaching Activities:

Various activities like debates, topic presentations are taken by Adv. Amit Dravid, subject teacher during the class alongside traditional teaching so as to give students practical approach of legal concepts. For Students of NLC-V and LLB-III, the debates on various practical labour questions such as 'Involvement of Outsiders in Trade Unions', 'Which will prevail: Standing Orders or Oral Guidelines issued by Occupier of the Factory', 'Notional Extension theory in Employees Compensation Act, 1923', 'Is it necessary to give statutory bonus if customary bonus is paid' etc are organized during the class. Latest Amendments also proposed Bills viz., Labour Code, 2020. are also discussed in the light of latest judgments. Assignments are taken in class so as to learn time management and to develop writing skills. To develop the knowledge of applied law, certified Standing Orders, actual enquiry proceedings etc are presented in class (The detailed report is given to concerned Faculty) For Students of LLM-I, the Mock Test ( MCQ Offline ) was organized for subject of ADR on 2nd February 2023. Also, to prevent online feuds, the university exam (MCQ) is also taken offline on 2nd March 2023 with permission of Dr. Deepa Patil, Principal, IMLC, Satara. While framing questions, the more attention is given to practical applications of ADR Techniques. (The detailed report is given to concerned LLM Faculty)

For subject RTI, students of LLM-II have given various practical examples as to utility of RTI Act, 2005. From filling up RTI Forms till appeal under RTI Act is explained by reference to actual information collected through RTI. Latest Judgments also discussed to get updated knowledge.
